Answer:

$$P = \text{Rs. } 5000, A = \text{Rs. } 6450, R = 12\%$$

$$\begin{aligned} \text{S.I.} &= A - P \\ &= 6450 - 5000 \\ &= \text{Rs. } 1450 \end{aligned}$$

$$\begin{aligned} T &= \frac{\text{S.I.} \times 100}{P \times R} = \frac{1450 \times 100}{5000 \times 12} \\ &= \frac{29}{12} \\ &= 2 \frac{5}{12} \\ &= 2 \text{ years } 5 \text{ months} \end{aligned}$$
